

CONSENT FORM FOR FJA EVENTS

The participant assumes all risks before, during and after the event, including personal injury, theft, loss or breaking of property. In addition, it releases **Francophonie Jeunesse de l'Alberta** from all liability and/or pursuit from an act of his or her own negligence.

If no contact persons can be reached in an emergency, the participant and parents/guardians authorize FJA to take all measures (medical treatment, hospitalization, X-rays, surgery) made necessary by the condition of the child. The parent or guardian will be responsible for ambulance fees, if necessary. The participant consents to inform FJA of any medication taken which is not included in the present form during the registration.

The participant agrees to abide by the event rules developed by FJA for the duration of the event (see the back of this form).

The participant and parents/guardian understand **no refund will be permitted after the registration deadline of the event**, unless approved by the Executive Director of Francophonie Jeunesse de l'Alberta. The participant and parent/guardian agrees to pay the fee in full at the time of registration to the person, institution or FJA staff that collect payments. This is communicated during the registration period.

The participant and parent/guardian accepts that a photo or video recording will be taken during the events and that these pictures or videos can be used for advertising purposes.

A. USE OF FRENCH

French is the language to be spoken at all FJA events. French must be used at all times during all events and activities.

B. ALCOHOL, DRUGS, TOBACCO, MARIJUANA ET VAPING

- Alcohol is prohibited during the events of FJA, for all participants, employees and supervisors.
- The possession and use of drugs are strictly prohibited.
- The possession and use of tobacco and marijuana, and vaping for all participants are prohibited. *If a participant violates these regulations, his/her cigarettes and other items will be confiscated and his/her parents will be notified of his/her offense. The participant may be asked to leave the event at his/her own expense.*

C. LEAVEING THE ACTIVITY PREMISES

- Participants are not allowed to leave the event premises unless accompanied by a responsible adult identified by FJA (a liability waiver may need to be signed by the parent or guardian);
- A responsible adult will not accompany more than 15 participants outside the site of the event.
- Participation in the entirety of the event is expected. A group or participant leaving the event site must have received approval from the Executive Director of FJA, and their parent or guardian if the participant is under the age of 18.

D. RESPECT OF AUTHORITY

All participants are under the direct authority of FJA organization (employees, volunteers, supervisors, facilitators/animators etc.). During the event, the participant must show respect towards any person of authority. Any lack of respect will be referred directly to the school or the parents (according to the nature of the event) by FJA's Executive Director.

E. VANDALISM, DESTRUCTION OF PROPERTY, THEFT ET AGGRESSION

The participant and parent/ guardian are financially and legally responsible for:

- any damage inflicted to the premises, equipment and material;
- theft committed during the event;
- any physical or verbal assault against another person during event.

FJA will present a bill to the participant and parent/guardian for vandalism, destruction, or theft committed during the event.

F. LOST AND FOUND

All found and unclaimed objects during the activity will be kept for a period of one month during which they can be claimed at 780-469-1344.

G. TIDINESS OF PREMISES

Each participant is responsible for keeping the premises and facilities clean during the event.

The consequences of non-compliance with these regulations will be supported by Francophonie Jeunesse de l'Alberta and/or the school according to the policies established by the Board of Directors of the organism.
